Update on Activities

Highlights for the Quarter

- Key Petroleum Limited (“Key” or “the Company”) continues to advance its interests in the Cooper–Eromanga Basin in Queensland. The Company’s eight Potential Commercial Area (**PCA**) applications across ATP 920 and ATP 924 remain under consideration by the Queensland Government. As at September 2025, the system indicates that they are at the decision stage, which indicates that approval is imminent. However, formal approval has not yet been granted. The Company has been following up on the status of the applications and will update the market in accordance with its continuous disclosure obligations once there are any material developments, including if approval is granted.

PCA approval represents a critical milestone for the Company, as it would grant two 15-year permits and establish a long-term foundation for development planning, partner engagement and funding activities. Once approval is secured, the Company intends to promptly commence the necessary technical studies to support the next phase of development and unlock the full value of the PCAs.

- On 19 March 2026, the Company successfully completed a share placement, issuing 1,015,286 fully paid ordinary shares (representing 3% of the Company’s issued capital). The funds raised will be applied towards working capital requirements and the continued identification and assessment of energy project opportunities.
- In January 2026, Jujun Zhang was appointed as an Executive Director, Vice Chairman of the Board, and CEO of the Company. Mr. Zhang brings extensive experience in energy project management, operations, and investment, particularly in the new energy sector, and will provide strategic guidance and support for the Company’s future development. Mr. Zhang is also one of the Company’s major shareholders and will leverage his resources outside Australia to assist the Company in expanding both its traditional and new energy businesses.

Activities for the Upcoming Quarter

- Given recent global developments and increased market interest in fossil energy projects, the Company intends to engage with potential partners and investment banks to explore funding opportunities, while also seeking to meet with relevant government authorities to facilitate the approval process. Securing PCA approval remains a key priority, as it would enable the Company to progress development planning and advance its oil and gas assets.
- The Company continues to actively manage its financial position. Regardless of the timing of PCA approvals, securing appropriate funding remains a key priority to support ongoing operations and project development.
- In the second quarter of 2026, the Company will focus on assessing potential capital management initiatives, including the possible issue of new shares, to support ongoing business development.

- The Company continues to progress PCA approvals and its existing oil and gas activities. In parallel, it is undertaking a preliminary review of potential opportunities in the new energy sector. As part of this initial review, the Company has identified solar energy as one area of interest, having regard to broader industry developments and its potential role in the evolving energy mix. Factors such as increasing electricity demand, including from data and technology-driven applications and the relatively lower capital intensity and shorter development timeframes associated with solar projects, have been noted. The Company remains at an early-stage assessment phase and, subject to further evaluation, may explore potential opportunities and collaborations in Australia, Asia and Africa. The Company's primary focus remains on progressing its existing oil and gas portfolio. Any potential involvement in new energy initiatives will be considered on a disciplined and opportunistic basis, with a focus on supporting long-term shareholder value.

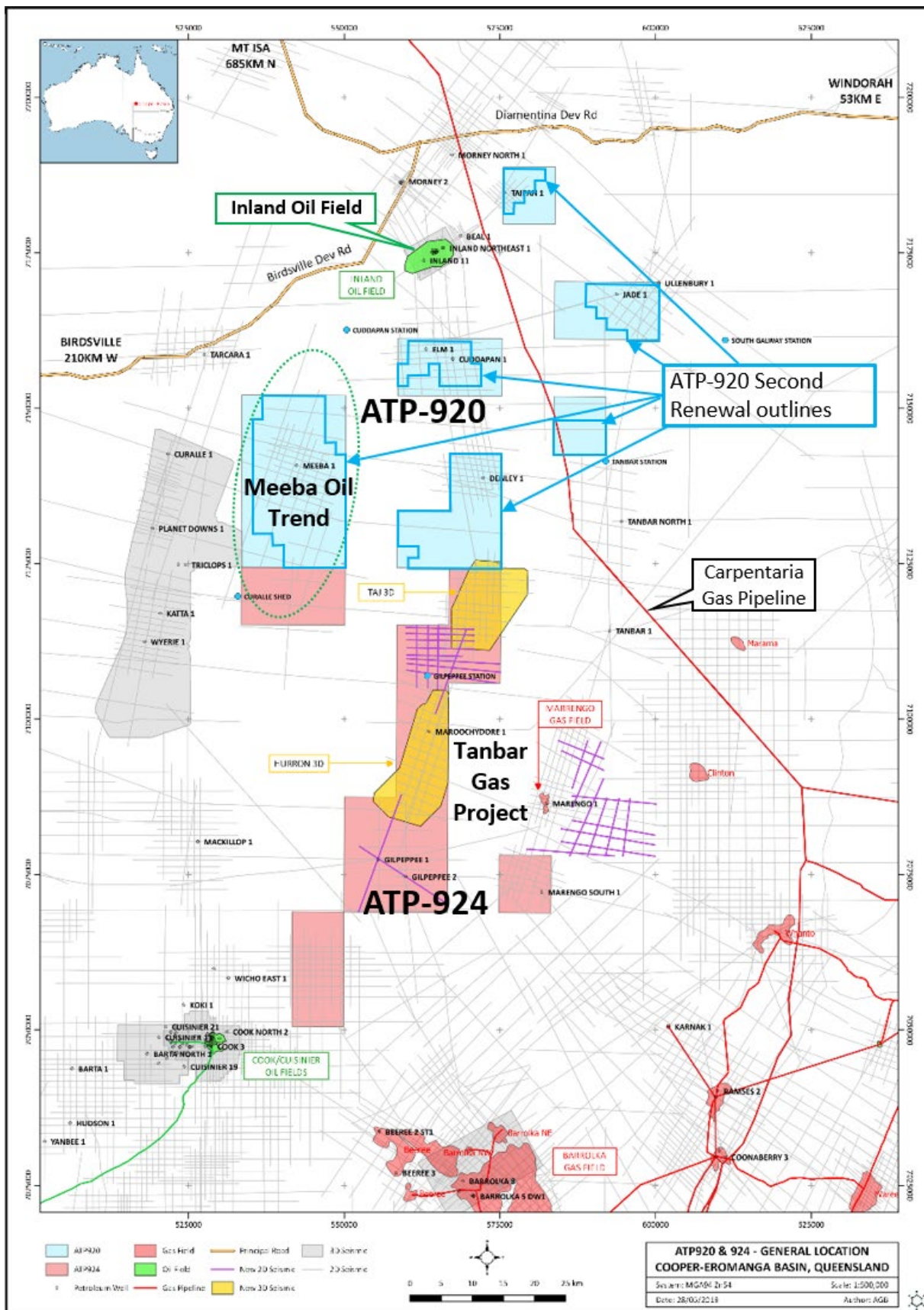


Figure 1: Impact of Lake Eyre Basin boundaries on ATPs 920 and 924.

Corporate and Current Outlook for Key

- As of the end of the December 2025 quarter, Key Petroleum Limited had A\$137,501.70 in cash on hand.
- Key is confident in its ability to meet operational needs in the coming quarters and has the ability to pursue additional funding options as needed with the support of shareholders willing to step in and assist.
- During the quarter, the Company paid the amounts noted at Items 6.1 and 6.2 on the Appendix 5B, being payments of \$24,000 to related parties and their associates. This was the aggregate amount paid to the directors including directors' fees and consulting fees (\$24,000).
